* This summary shows changes from current law under the bill for each fiscal year.

Summary of Legislation

This bill, **as amended by the House Education Committee**, changes the "Public School Finance Act of 1994" by modifying the funding for K-12 public schools in FY 2015-16. The bill increases base per pupil funding to \$6,292, to reflect a 2.8 percent inflation rate. Beginning in FY 2015-16, the bill also makes the following changes in the calculation of total program:

- reduces the amount of the negative factor in FY 2015-16 by \$25 million from the FY 2014-15 level; and
- specifies that for FY 2016-17, the negative factor cannot exceed the FY 2015-16 level.

In addition, the amended bill repeals the minimum state aid requirement that had been suspended through FY 2014-15, but was to be reinstated in FY 2015-16 under current law. It also increases by \$5 million annually the amount of interest and income to be transferred from the Public School Fund to the State Public School Fund, and requires that this money be appropriated to school districts and institute charter schools on a per at-risk pupil basis, outside of the school finance formula.

State Transfers

Beginning in FY 2015-16, the amended bill increases by \$5 million annually the amount of interest and income on moneys in the Public School Fund that is to be transferred to the State Public School Fund.

State Expenditures

Total Program Funding. Senate Bill 15-267 sets total program funding for FY 2015-16 at \$6.240 billion. This represents a 12.13 percent reduction from what funding levels would have been without the negative factor. The appendix details the funding changes that occur at the school district level as a result of this bill.

The \$6.240 billion in total program funding represents an estimated increase of \$306.1 million in FY 2015-16 compared with actual funding levels for FY 2014-15, and increases formula funding by \$25.0 million for FY 2015-16 relative to current law. State expenditures for school finance will increase by \$25.0 million, with local funding remaining unchanged. Since the negative factor is set at 12.13 percent, each district's total program funding will be reduced by 12.13 percent from the level set by the funding formula before application of the negative factor, provided the district receives at least an amount of state aid that is greater than this percentage reduction. Table 1 shows the estimate of school finance act funding under Senate Bill 15-267.

Negative Factor in FY 2016-17. The bill specifies that the negative factor in FY 2016-17 may not exceed the level set in FY 2015-16. Since current law does not define the negative factor in FY 2016-17, it is not possible to quantify the fiscal impact of this provision.

Repeal Minimum State Aid Requirement. By repealing the minimum state aid requirement, the bill will reduce the state share and increase the local share by an estimated \$607,866 and \$407,862, respectively, in FY 2015-16. Current law contains a provision that ensures a minimum level of state aid per pupil, including school districts that would otherwise fully fund total program with local revenue. The General Assembly calculates the annual minimum state aid per pupil based on anticipated revenue from a variety of sources. House Bill 10-1318 suspended the minimum state aid provision from FY 2010-11 through FY 2014-15 and this bill will repeal it entirely.

At-Risk Supplemental Funding. For 2015-16 and each fiscal year thereafter, the amended bill requires the appropriation of \$5 million to the CDE for distribution to school districts and institute charter schools. The bill defines this distribution as "per at-risk pupil additional funding" and requires its distribution to each district and institute charter school that enrolls one or more at-risk pupils. The bill specifies that this distribution is to supplement traditional at-risk funding that occurs through the school finance formula. It is currently anticipated that this funding will be distributed among just under 310,000 students which implies that districts and institute charter schools would get \$16.13 per at-risk pupil in supplemental at-risk funding.

School District Impact

Table 1 above shows the estimate of school finance act funding under Senate Bill 15-267. The table compares estimated FY 2015-16 funding levels with actual funding in the prior year. In FY 2015-16, the bill increases funding by \$268 per pupil and funds 10,845 new pupils. Total program funding increases from \$5.933 billion to \$6.240 billion. Of this amount, the state's share increases by \$163 million, from \$3.951 billion to \$4.113 billion. The appendix to this fiscal note contains a district-by-district overview of the school finance impacts of Senate Bill 15-267.

In addition, beginning in FY 2015-16, each school district and institute charter school will receive supplemental at-risk funding in the amount of \$16.13 per at-risk pupil.

Pursuant to Section 22-32-143, C.R.S., school districts and Boards of Cooperative Educational Services (BOCES) may submit estimates of fiscal impacts within seven days of a bill's introduction. As of the date of this fiscal note, no summaries of fiscal impacts were submitted by districts or BOCES for this bill. Technical or Mechanical Defects

L.025, passed in the House Education Committee, requires a \$5 million increase in the amount of money transferred from the Public School Fund to the State Public School Fund, beginning in FY 2014-15. It should have read beginning in FY 2015-16.

Effective Date

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

State Appropriations

For FY 2015-16, the bill requires the following General Fund appropriation:

- \$25,000,000 to the Department of Education for the state's share of total program.

For FY 2015-16, the bill requires the following cash funds appropriation:

- \$5,000,000 to the Department of Education from the State Public School Fund for supplemental at-risk funding.
