Purposes for which use of state education moneys is statutorily authorized¹

Paying the costs incurred by school districts and charter schools in administering basic skills placement or assessment tests (§22-2-112 (4), C.R.S.)

Creating a resource bank of materials pertaining to financial literacy (§22-2-127 (5), C.R.S.)

Creating state residential schools and providing technical assistance to school districts and public schools to improve secondary-level mathematics and science curricula (§22-2-137, C.R.S.)

Purchasing an early literacy assessment tool for the use of local education providers (§22-2-141, C.R.S.)

Creating and implementing a data dictionary for use by the department of education and school districts (§22-2-305, C.R.S.)

Funding the facility schools unit within the department of education and the student data system for students in facility schools (§§22-2-401 et seq., C.R.S.)

Implementing the teaching and learning conditions survey and paying stipends to teachers or principals who hold national board certification (§§22-2-501 et seq., C.R.S.)

Providing funding to BOCES to assist districts in implementing and meeting state educational priorities (§22-5-122, C.R.S.)

Providing funding for twelve regional service areas (§§22-5.5-101 et seq., C.R.S.)

Paying the costs of updating statewide assessments and reviewing the administration and security policies to maintain the integrity of the statewide assessments (§22-7-409 (4), C.R.S.)

Adopting and implementing the school readiness description, statewide standards and aligned assessments, and a postsecondary and workforce readiness description ("Preschool to Postsecondary Alignment Education Alignment Act", §§22-7-1001 et seq., C.R.S.)

Providing instructional programming, intervention instruction, and support to ensure that students are reading at grade level by the completion of 3rd grade ("Colorado READ Act", §§22-7-1201 et seq., C.R.S.)

Implementing the state council for educator effectiveness (§§22-9-105.5 and 22-9-105.7, C.R.S.)

Paying the costs incurred by the department of education in reviewing school districts' licensed personnel evaluation systems (§22-9-106, C.R.S.)

Implementing the education accountability system ("Education Accountability Act of 2009", §§22-11-101 et seq., C.R.S.)

Funding the school leadership academy program (§§22-13-101 et seq., C.R.S.)

Supplementing the funding for children with one or more disabilities and for high cost special education services (§22-20-114, C.R.S.)

Funding for placing highly advanced 4- and 5-year-old gifted children in kindergarten and first grade (§22-20-204, C.R.S.)

Paying the costs incurred by the division of on-line learning in overseeing on-line programs and on-line schools (§22-30.7-107, C.R.S.)

Funding concurrent enrollment moneys ("Concurrent Enrollment Programs Act", §§22-35-101 et seq., C.R.S.)

Paying the costs of: averaging pupil enrollment over 5 budget years; expanding the definition of "at-risk pupils" to include English language learners and increasing the at-risk factor, generally and for high-concentration districts; and averaging of the number of at-risk pupils over 3 years ("Public School Finance Act of 1994", §§22-54-101 et seq., C.R.S.)

Paying the cost of requiring school districts to provide services to juveniles held in adult jails (§22-54-104.2, C.R.S.)

Funding capital construction for qualified charter schools (§22-54-124, C.R.S.)

Funding education for pupils placed in facility schools (§22-54-129, C.R.S.)

Providing technical training and support to districts that expand to full-day kindergarten programs (§22-54-131, C.R.S.)

Providing national credential fee assistance to teachers who obtain a national credential (§22-60.5-112.5, C.R.S.)

Funding the design and development of alternative teacher compensation plans (§22-69-102, C.R.S.)

Paying the costs of expanding the free lunch program in schools ("Child Nutrition School Lunch Protection Program Act", §§22-82.9-101 et seq., C.R.S.)

Funding grants to increase the availability of school counselors and the level of school counseling services (§22-91-104, C.R.S.)
